Award Categories

Lifetime Achievement Award

This award recognizes an extraordinary individual who has set a high standard for volunteerism, philanthropy and professional accomplishment, and has been an example for all who follow. The recipient must have received a degree from the Allard School of Law or be an honorary alumnus/alumna.

Alumni Award of Distinction

The Alumni Award of Distinction recognizes the outstanding achievements of an Allard School of Law alumnus/alumna whose endeavors in the practice of law, government service, the judiciary, business, legal academe, community service or other areas have brought honor to the school. The recipient need not have previously received public recognition for their endeavors, but must have made a significant contribution to his/her field.

Alumni Award for Research

The Alumni Award for Research recognizes a fulltime member of the Allard School of Law whose research achievements have advanced the Faculty's reputation as a leading research institution. The recipient need not be an alumnus/alumna of the school.

Outstanding Young Alumnus Award

This award recognizes an alumnus/alumna of the Allard School of Law under 40 years of age or in their first ten years of practice, whose endeavors in the practice of law, government service, the judiciary, business, legal academe, community service or other areas are worthy of recognition and have brought honor to the school.

Selection Criteria

1. Awards are not necessarily presented in all categories each year
2. More than one award may be presented in any category

Selection Committee

The make-up of the Alumni Award Selection Committee includes:

- three (3) members of the Association Board, recommended by the Association's President
- two (2) individuals appointed by the Dean of the Allard School of Law



PROCEDURES FOR NOMINATION SUBMISSION

Please complete the nomination form fully and legibly and attach/enclose supporting documentation with a reference to the candidate's name on each page. As we will copy the complete nomination package for our committee members, please ensure that the material you provide is clear. If we feel the nomination package is not complete or informative enough, we may contact you for more information.

Each nomination package must include:

- a fully completed nomination form
- a brief biographical sketch of the nominee (resumé or curriculum vitae is recommended)
- a clear and concise statement of 300 words or less which indicates why this candidate is deserving of the Alumni Award(s) for which he/she is nominated.

Additional supporting documentation may include:

- letters of reference (maximum 3)
- list of awards or other public recognition
- sample media reports, plus reference list of other media reports
- other information deemed pertinent by the nominator

Confidentiality is assured: nominations will be handled in a professional and secure manner. Nominators may, at their discretion, inform nominees that they have been nominated. The Alumni Association will only notify winners after first informing nominators of the selection.

A law alumni selection committee will review all nominations and will recommend award recipients for approval by the Association's Board of Directors. Nominations will remain on file for three years.
